He is an Advocate-on-Record at the Supreme Court of India and has argued cases on diverse fields of law before the Supreme Court (including its Constitution Benches), various High Courts and Tribunals in the country. He devotes a substantial part of his professional time for *pro bono* work on behalf of the disadvantaged sections of society lacking access to Courts, such as bonded labour and

mentally ill persons, and for taking up causes in Court for disempowered victims of injustice. He has prepared the ADR preparatory material for the All-India Bar Examination conducted annually by the Bar Council of India. The book, Unravelling the Kashmir Knot, a SAGE bestseller, which pieces together a practical, and novel, the solution to the Kashmir issue has been written by him.
