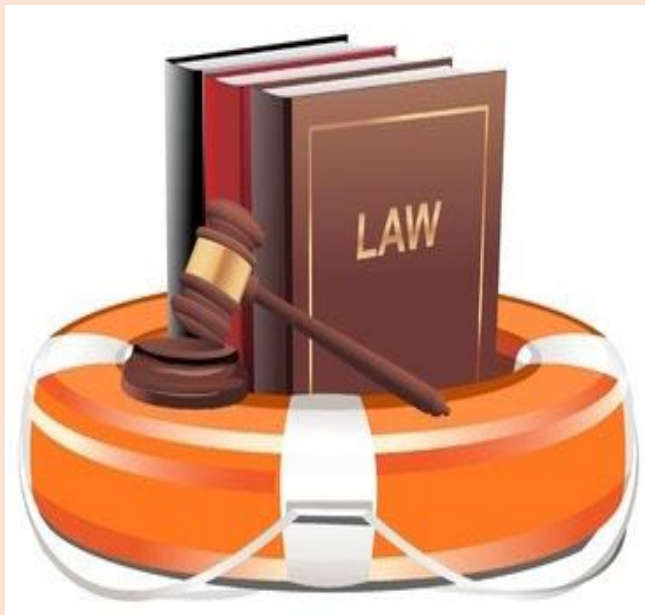

TERM OF SERVICE OF THE MEMBER'S OF DISTRICT FORUM

The Consumer Protection Act, 1986.

Section 10 (2)

Every member of the District Forum shall hold office for a term of five years or up to the age of sixty-five years, whichever is earlier.

Provided that a member shall be eligible for re-appointment for another term of five years or up to the age of sixty-five years, whichever is earlier.

The Consumer Protection (Rajasthan) Rule, 1987.

The Rule does not mentioned anything about the terms of service of the members of the district forum.

- The internship will be virtual/online in nature and all the communications will be done through e-mail. Interns are expected to be well versed with basic research skills and must be

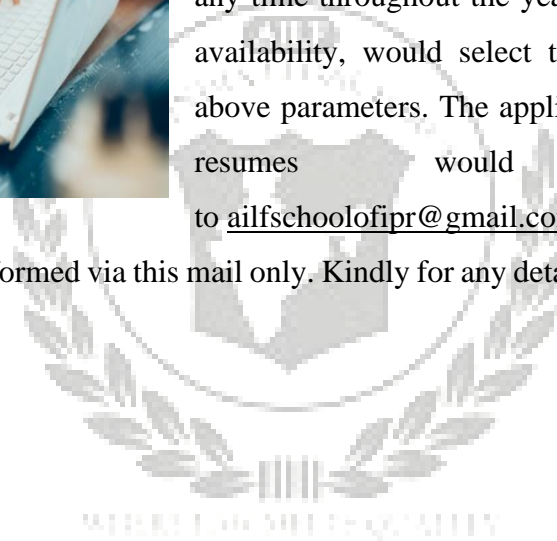
familiar with the usage of legal databases such as SCC Online, Manupatra, etc. The majority of the work includes:
